Fleet report - Vince Earl

Additional comments:-

K13 EOE will go to Rattlesden for the winter period.

Allen agreed to fit G meters & radios where required in the fleet gliders.

Dave H requested a mechanical vario should be fitted if not already present – agreed.

Two e-varios required, buy one from Matt Jones at £150 – agreed. Allen to provide second e-vario, price tba – agreed in principal.

The "Light weight" Astir to be sold, it is understood that members Jake & Nick are interested in purchasing, Mike H to seek confirmation about possible purchase from Jake & Nick. Offer price agreed at £3250 for the Astir + use of trailer when not required by club.

Winch report - Will Burry

Problems with cable chutes being heavy and falling too fast, causing more damage from off airfield retrieving.

WB to enquire about new chutes from Wormingford.

Currently there are a total of 8 winch drivers, more members need to be encouraged to participate.

Recent incident with a dog walker and off lead dog, where the dog was seen by the winch driver heading towards a live cable, launch in progress, with dog owner in hot pursuit. Fortunately the dog did not get too close to the cable and the owner realised what was happening and stopped.

Committee agreed that better warning is required for dog walkers & others when winch launching is taking place.

Close off path entrances to field when winching, with barriers & suitable notices.

Will B to investigate suitable solutions and implement – ask for help as and when required.

Planning - Steve Jessop

Environmental report on proposed site available upon request.

Various options for the small pond near the concrete straw stack base were discussed regarding compliance with Crested Newt preservation regulations.

It was decided that a DNA Newt test should be carried out to determine if any Newts currently exist in the pond. To comply with DEFRA any tests have to be carried out by certified company that is compliant with all of DEFRA's requirements.

This could pose a considerable cost – SJ to investigate further.

Steve will get tree saplings to fill in gaps around the compound prior to applying for planning permission, cost in the order of £30 - £40; agreed.

Sale going ahead albeit at a slow pace at the moment, no problems anticipated.

Changes to fees:-

Adult standard membership to remain at £350 / year.

The Under 25 option is cancelled and will no longer be available.

Outside toilet and kitchen water heaters to be swapped over, the kitchen heater has an "On demand" temperature control, SJ & AC

This will negate the toilet water heater being left on and wasting electricity, once fitted into the kitchen its control can be monitored easier.
